Applicant Portal Enhancements

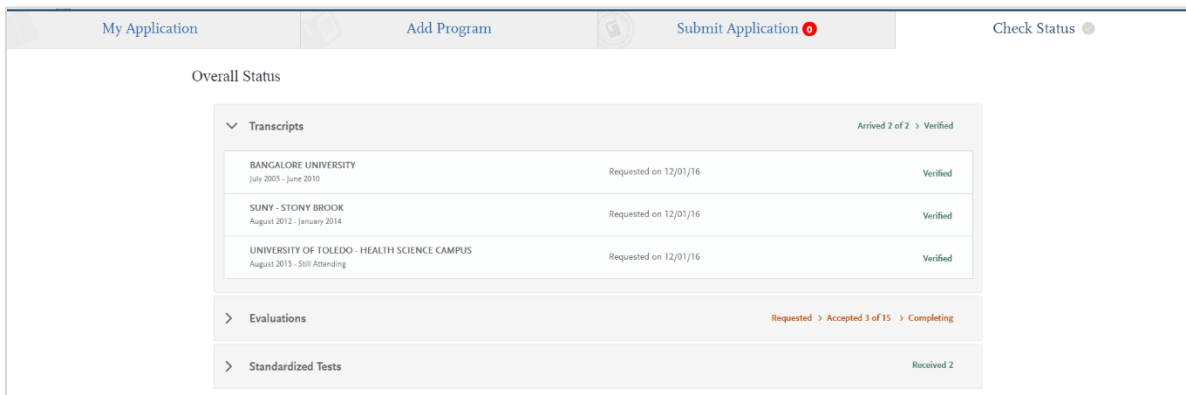
The following enhancements are available for WebAdMIT as part of Sprint 13.

Updated Check Status Page

The **Check Status** page has been updated with several enhancements.

Cleaner, Easier to Navigate Interface

The **Check Status** tab (including Test scores, Transcripts, Evaluations, and Programs) has been updated with a more focused, streamlined look.



This includes the ability to download application PDFs directly from the **My Programs** section.

New Legal Sex (Gender) Section

An updated version of the **Gender** question is now available in the **Biographic Information** section. You can now opt to use a **Legal Sex** version of the question that contains options related to sexual orientation, gender identity, and gender expression.


New WebAdMIT Support Number

The WebAdMIT Support phone number has been updated. With our new number, **857-304-2020**, callers will no longer need to select from a menu when dialing in.


Available Documents Indicator

Note that this enhancement is immediately available in WebAdMIT and does not require any configuration.

You can now view the number of documents submitted by or uploaded for applicants on the **Documents** subpanels. As documents are processed by the CAS, the numbers will automatically update. When you manually upload documents under the **Admissions Uploaded Documents** subpanel, you must refresh the applicant's page to view the updated document number.

Resolved Issues

WebAdMIT

The following issues are resolved in WebAdMIT as part of the Sprint 13 release. The codes in parentheses correspond to the identifiers in our issue tracking system.

1. The Countries table in WebAdMIT was updated to match the CAS database for all CAS cycles. This resolves an issue where Country data was missing from some applicant exports. (WA-4879)
2. An issue that prevented users from bulk updating custom fields for applicant lists, search results, and clipboards was resolved. (WA-4859)
3. A display issue where long field names did not display correctly in the field select drop-down lists was resolved. (WA-4570)
4. The message that appears when you delete a report in the Report Manager now says, “Are you sure you want to delete these report settings?” Previously, it incorrectly said, “Are you sure you want to delete these export settings?” (WA-4567)
5. An issue that caused an error to occur when searching on blank fields in the Export Manager was resolved. (WA-4377)
6. Applicant Gateway activities now expire at the appropriate time. Previously, certain deadlines were expiring at the beginning of the specified day, rather than the end. (WA-4887)

Applicant Portal

The following issues are resolved in the Applicant Portal as part of the Sprint 13 release. The codes in parentheses correspond to the identifiers in our issue tracking system.

1. The correct fields now display on the **Standardized Tests** pages when applicants enter MCAT test scores with test dates in January 2015. Previously, the fields displayed were for post-January 2015 test entries. (UNCAS-13269)
2. The correct Start Year now displays on the **Home** tab on the **Program Materials** page. (UNCAS-13268)
