## Resolved Issues

### WebAdMIT

The following issues are resolved in WebAdMIT as part of the Sprint 7 release. The codes in parentheses correspond to the identifiers in our issue tracking system.

1. The **Primary College** filter can now be used when exporting CEEB, FICE, and IPEDs codes in the Export Manager. (WA-4652)
2. An issue that in limited instances caused inconsistencies in the ethnicity reports was resolved. (WA-4633)
3. An issue related to the way WebAdMIT limits the overall size of admissions uploaded documents was resolved. The limit is now enforced per applicant per organization, rather than just per applicant. (WA-4607)
4. The **Group by Course Number** option in the Electronic Transcript now works correctly when prefixes/course numbers begin with a number. (WA-4597)

### Applicant Portal

The following issues are resolved in the Applicant Portal as part of the Sprint 7 release. The codes in parentheses correspond to the identifiers in our issue tracking system.

1. Applicants can now enter Completed and In Progress degrees for the same college in the **Colleges Attended** section. (UNCAS-11759)
2. Updates made to an applicant's ethnicity in the Applicant Portal are now reflected correctly in WebAdMIT. (UNCAS-10949)

### Evaluator Portal

The following issues are resolved in the Evaluator Portal as part of the Sprint 7 release. The codes in parentheses correspond to the identifiers in our issue tracking system.

1. Non-standard and blank zip/postal codes can now be entered in the **Contact Information** section to account for evaluators with foreign addresses. In previous versions, the Evaluator Portal only accepted zip/postal codes in US and Canadian formats. (UNCAS-11285)
