
WebAdMIT Enhancements

The following enhancements are available for WebAdMIT as part of Sprint 20.

Lists, Exports, and Reports Can Be Made Viewable to Work Groups

All CASs will have access to this feature beginning in the 2018-2019 cycle. This feature can be activated for the current cycle upon request. Contact your Account Manager if you have any questions.

We are pleased to announce that for CASs operating in the 2018-2019 cycle, Lists, Exports, and Reports can be shared with selected Work Groups. Rather than making an item visible to only “Myself” or “Everyone,” it can be made viewable to all users in the Work Group(s) of your choosing.

Updated Display of Optional/Required fields on the Applicant Portal	Mid-Fall	<p>Later this fall, the Applicant Portal will be updated to make it easier for applicants to see which fields are optional and which are required when completing the application.</p>
Updates to Lookup Tables	Mid-Fall	<p>Many fields in the application contain predefined answer values that users can select; for example, the Country and College Name fields both have predefined answer values. These values are housed in “lookup tables”, which are updated twice a year. The next update is scheduled for mid-fall.</p> <p>To find which lookup tables will be updated, and the changes in the predefined answer values, you can refer to your Custom Export Field Layout file, accessible under Support Resources in WebAdMIT.</p>

Resolved Issues

WebAdMIT

The following issues are resolved in WebAdMIT as part of the Sprint 20 release. The codes in parentheses correspond to the identifiers in our issue tracking system.

1. An issue causing the State of Residence report to not calculate correctly was resolved. (WA-5027)
2. An issue with duplicate Supplemental Question blocks was resolved. (WA-5088)
3. An issue causing errors in the Scoring panel when using 'Highest Overall' OAT scores was resolved. (WA-5086)
4. An issue causing errors when editing Lists, Reports, and Exports was resolved. (WA-5084)
5. An issue allowing newly approved advisor accounts to overwrite preexisting WebAdMIT accounts was resolved. (WA-5037)
